### Treasurer, Doris C.

- Vernon called the meeting to order and distributed the agenda.
- Vernon asked Kim to record the minutes. Kim accepted.

### Approval of Agenda:

- Ron discussed some of the neighbors' concerns regarding the condition of the gravel roads and advocated for proaction.
- Discussed back ups for Tim Green's road maintenance services.
- Discussed concerns about the gravel road from neighbors and our financial ability to address. Reviewed
  expenditures on gravel vs paved section of road for the past years listed on the financial report. Discussed
  the needs to build the gravel road back up in order for grading to hold up due to hitting the bedrock beneath
  the road.
- Bob made a motion to complete the paving job and the necessary work on the gravel road. Ron seconded.
   All voted in favor.
- Discussed intentions to do the major work needed on the gravel road in the future when reserve funds are replenished. Bob made a motion to get formal estimates on the job from at least two qualified contractors.

In discussion, Ron gave 1 name and phone number, Doris gave 2 additional names and numbers. Ron second, all voted in favor.

• Discussed doing it "soon" and it was agreed not to put a time limit on it, but we would proceed with the estimates immediately and move the project along as funds allow.
